# FLEA MARKET REGULATIONS

## **NO Thursday Set Up Allowed without Prior Approval – NO Wednesday Set Up!**

1. An exhibitor who applies for a lot must be at least eighteen (18) years of age and is responsible for any minor working for the applicant. **Absolutely NO food or beverages may be sold.**
2. No hats, caps, shirts, shorts, or other clothing displaying a Blueberry logo or lettering related to the Blueberry Festival, or any other Blueberry related items are allowed to be sold by vendors that would be in competition with such items of like nature sold in the Montrose Blueberry Festival Stores. If in doubt, please check with the Flea Market Committee. **By city ordinance, no pornographic or other offensive books, clothing, visual materials, food or drinks, prohibited substances or drug paraphernalia may be sold at the festival.** Drug paraphernalia includes but is not limited to roach clips, crack pipes, and other items deemed drug related by festival or City of Montrose officials. **Failure to heed this rule will result in eviction without reimbursement of your lot fee.**
3. Some site numbers have been changed; please bear with us as we merge Craft show vendors on one end of the park. We cannot guarantee you will receive the same space as in previous years.
4. Each exhibitor must assume full responsibility for his/her own work and is expected to be present during the days of the festival. We have no undercover facilities in case of a storm, so we suggest you bring your own protection.
5. Exhibitors are responsible for setting up his/her own display area and having their own tools, table, chairs, etc. Flea Market lot sizes are approximately 18' x 20' fronting wide walkways. Please locate your display in such a way that it leaves the walkway clear for traffic. Sites are rustic and do not include utilities. Fines of up to \$150 will be incurred if any vendor hooks up to park utilities for any reason. If you need electricity, please provide your own quiet generator.
6. After unloading your vehicle, it must be removed to a nearby parking area unless you have made arrangements for its use with the committee or have indicated your desire to camp on site. If you are keeping your vehicle at your site, you will not be allowed to drive it out of the park until the show closes at 5 p.m. on Sunday.
7. **You will not be assigned a space without payment included with your application. Confirmations will be sent by mail only if a self-addressed, self-stamped envelope is included in your entry.** All other confirmations will be via e-mail or by viewing online at [www.montroseblueberryfestival.net](http://www.montroseblueberryfestival.net). We cannot guarantee you will receive the same space as in previous years.
8. Camping by RV's is available on site and in the campground area to the east of the tennis court on Feher Drive. Onsite camping for Flea Market exhibitors is absolutely FREE, but please let the flea market director know your intentions. Your camper must fit in your paid space, and may not encroach on neighboring spaces. There are no utilities included in either area.
9. You are responsible for cleaning your space prior to leaving the area on the day the show closes. The festival will provide you with two trash bags. Please use them for bagging your trash and break down all your boxes. **ALL TRASH MUST BE TAKEN TO THE ROLLOFF ACROSS THE STREET AT THE SCHOOL. Do NOT leave any trash on your site for us to clean up!**
10. Registration forms should be received not later than August 9<sup>th</sup> to assure you a space, however; we will accept exhibitors up until Fri. Aug. 20<sup>th</sup>, regardless if they have pre-registered. **Cash or money order only if payment is made during on-site registration—no checks will be accepted after Friday, Aug. 13<sup>th</sup>.** The entry fee is a \$75 flat fee per lot for the entire weekend of the festival. Payment is fixed regardless of what day you intend to arrive.
11. No exhibitor may change lots or allow another person to use his/her lot unless arrangements have been made with the committee. Exhibitors are required to stay within the lot space they have rented. Campers and RV's must not encroach on neighboring spaces.
12. On-site registration for those arriving on Friday will begin approximately at 8:00 a.m. On Saturday morning, set ups no earlier than 8:00 a.m. are allowed. The registration area will be in the park pavilion. ALL vendors should check in at the registration booth in the city park pavilion BEFORE set-up. There will be signs on M-57 and city streets giving directions to the area.
13. Refund requests must be made at least one week prior to the festival and a handling fee will be deducted from the amount previously paid. Absolutely no refunds after August 13, 2021. Approved refunds will be mailed out no later than September 30, 2021. There will be no refunds issued for failure to attend the festival for any reason.
14. **ABSOLUTELY NO FOOD OR BEVERAGES (INCLUDING WATER) MAY BE SOLD BY FLEA MARKET VENDORS. NO EXCEPTIONS! GENESEE COUNTY HEALTH DEPARTMENT REGULATIONS APPLY.**
